1 TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:

2 PLEASE TAKE NOTICE THAT, on June 22, 2012, at 9:00 a.m., Plaintiff New Jersey  
3 Carpenters Pension Fund will appear through Court appointed Counsel for the Settlement Class,  
4 in Department 1 of the Superior Court of California, County of Santa Clara, located at 191 North  
5 First Street, San Jose, California 95113, to move the Court, the Honorable James P. Kleinberg,  
6 Superior Court Judge presiding, for an order granting final approval of the settlement (the  
7 “Motion”). The Stipulation of Settlement resolves the shareholder claims asserted in the above-  
8 captioned action (the “California Action”), as well as the related shareholder class action pending  
9 in the Delaware Court of Chancery, entitled *Danielo v. NetLogic Microsystems, Inc., et. al.*, C.A.  
10 No. 6881-VCG (the “Delaware Action,” collectively with the California Action, are the  
11 “Actions”).

12 The Motion seeks entry of an Order granting: (1) Final Approval of Settlement under  
13 California Rule of Court 3.769(c); (2) Certification of the Settlement Class (as defined in the  
14 Stipulation<sup>1</sup>) under California Rule of Court 3.769(d); and (3) an Award of Attorneys’ Fees and  
15 Expenses to be awarded to Plaintiffs’ Counsel in the Actions.

22 <sup>1</sup> The proposed Settlement Class, as defined in the Stipulation of Settlement, consists of “any and  
23 all record holders and beneficial owners of NetLogic’s common stock, including any and all of  
24 each such holder’s respective successors, successors in interest, predecessors, predecessors in  
25 interests, representatives, trustees, executors, administrators, heirs, assigns or transferees,  
26 immediate and remote, and any person or entity acting for or on behalf of, or claiming under, any  
27 of them, and each of them, who held shares of NetLogic’s common stock at any time between  
28 and including September 12, 2011 and the date of consummation of the Merger. Excluded from  
the Class are the Defendants, members of the immediate family of any Defendant, any entity in  
which a Defendant has or had a controlling interest, officers or directors of NetLogic or  
Broadcom, and the legal representatives, heirs, successors or assigns of any such excluded  
person.”

1           The Motion is based on the Stipulation, the accompanying memorandum of points and  
2 authorities, the Declaration of David E. Azar in support of the Motion and the exhibits thereto,  
3 including the Fee Declarations, and such additional evidence or argument as may be requested,  
4 presented, or required by the Court.
